OMSA Vessel Security Plan Program Changes Provider

The USCG has cancelled their Marine Inspection Notice 03-12 on expanded carriage of Official Logbooks by US-flag inspected vessels. For now, vessel operators may return to past log use and carriage practices pending amplified guidance to be provided by the USCG in the near future.

On March 12, 2012 the Office of Vessel Activities (now the Office of Commercial Vessel Compliance, CG-CVC) released MIN 03-12 to announce additional logbook and entry requirements under 46 U.S.C. §11304. In that notice OCMIs were directed to notify vessel operators of the new law and subsequently begin checking for compliance during routine inspection activities. Since the release of the notice, we have been made aware of different interpretations on the law's applicability with regard to certain vessel types. In addition, numerous questions were raised concerning specific entry formats that would be accepted by the Coast Guard.

The Office of Commercial Vessel Compliance (CG-CVC) is currently working with the Vessel

and Facility Operating Standards Division (CG-OES-2), the Office of Regulation and Administrative Law (CG-0943), and the Office of Maritime and International Law (CG-0941) to establish and communicate the appropriate applicability of this new statute and to determine acceptable formats for the entry requirements. Once these determinations are made, further guidance will be published.

Making Safety Personal: 2 seconds matter:



This Month is Distracted Driving Awareness Month, so I've got a question for you. How many of you have ever used your cell phone while driving? How many of you have been a passenger in a car when the driver was using their phone? How many of you have come close to having an accident because you were a distracted driver when using a phone, or the passenger of someone using a phone. The "Yeah I know it's risky to text or talk and drive and that people get hurt or killed, but it won't happen to me," thinking didn't work for over 3,000 people who lost their lives, and thousands more who were injured due to distracted driving in 2010 alone.

More often than not, teens are part of these tragedies. Teenagers are four times more likely to crash than adult drivers. In fact, crashes remain the leading cause of death for their age group. Over the last 20 years, alcohol related fatal accidents have dropped by about 60%, but other fatal crashes for teens have gone up by about 35%. Basically, we've just traded drunk driving for distracted driving." Please be aware of the hazards associated with distracted driving.
